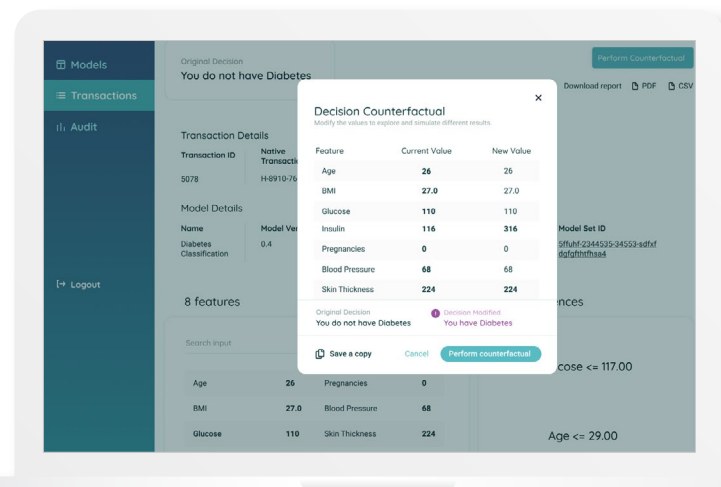


As ML models encounter new data and change how they operate, Monitaur ensures that you know when variances arise and can take corrective action before issues spiral.
